ANNEX 1: TERMS OF REFERENCE

RECRUITEMENT OF A JUNIOR BACKEND DEVELOPER

1. INTRODUCTION / CONTEXTE

The **African Development Bank Group (AfDB)** is a regional multilateral development finance institution established in 1963 with a mandate to further the economic development and social progress of African countries, individually and collectively. The Bank has approximately over 2000 staff members, who have been recruited from a wide geographic area only limited by membership in the Bank. The Bank has two official languages: English and French. It co-operates with a large network of international development partners.

The **Corporate IT Services department (TCIS)** is responsible for the provision of efficient, effective and modern IT infrastructure and application services to support optimize and transform Bank's business process for developing Africa. Under the leadership of the Bank's Corporate IT Services Senior Director and CIO, TCIS department is mandated by the Bank to deliver the best possible IT services for Bank staff and help achieve the results that will get the Bank closer to accomplishing its development goals.

2. OBJECTIVE

In the framework of the Bank's **Digital Ambition 2030**, the Applications and Innovation Division (TCIS1) leads software development, drives innovation, and aligns IT projects with the business needs of the Bank, ensuring technological advancements are in harmony with organizational goals. 3. SCOPE OF THE SERVICES

The consultant's duties will be as follows:

- Develop and maintain RESTful APIs and server-side applications using modern programming languages and frameworks.
- Architect and implement scalable and secure backend systems.
- Collaborate with front-end developers and other stakeholders to define system requirements and integration points.
- Design and manage relational (e.g., MySQL, Oracle, MSSQL) and/or NoSQL databases (e.g., MongoDB).
- Write efficient queries, optimize database performance, and ensure data integrity.
- Adopt Secure coding principles and implement security best practices including data encryption, secure authentication, and authorization.

- Perform regular performance testing and optimization of backend services.
- Develop and execute unit tests and integration tests to ensure code quality.
- Document the architecture, codebase, and API endpoints.
- Provide technical support and maintenance for existing backend applications, troubleshooting and resolving issues as they arise.
- Assist in setting up and maintaining CI/CD pipelines for automated testing and deployment.

4. DELIVERABLES

The following is the list of expected deliverables during the assignment:

- Fully developed and tested RESTful APIs and backend applications.
- Performance and security optimization reports.
- Regular progress updates and participation in agile development meetings.
- A deployment-ready codebase integrated with the organization's CI/CD pipeline.
- Use Security by Design principles to implement OWASP top 10 best practices to mitigate potential code vulnerabilities.
- Detailed technical documentation covering system architecture, codebase, and API usage.
- Maintenance of existing applications and continual support on applications and data integrations for data consistency and accuracy across the Information System;
- Full documentation of the developed solutions and store these codes into the Bank source code repository.

5. QUALIFICATIONS

- Master's degree or engineering degree in computer science or any engineering course
- Candidate must be less than 32 years of age.
- Multi-lingual ability will be an advantage.

6. PROFESSIONAL EXPERIENCE

- Between 2- and 4-years' experience in building web and cloud applications
- Knowledge of Object-Oriented design and programming skills
- Proficiency in server-side programming languages (e.g., Node.js, Python, Java, PHP).

- Proven experience with backend frameworks and API development
- Familiarity with queries, database performance optimization and, API optimization.
- Strong knowledge of database design and management (SQL and/or NoSQL).
- Familiarity with security best practices, authentication, and authorization techniques.
- Collaborative problem-solving skills within cross-functional teams
- Debugging and performance optimization skills
- At least one cloud practitioner certification e.g. Azure practitioner, AWS Cloud Practitioner or OCI cloud practitioner
- Integration with RESTful APIs and third-party services
- Good understanding of Version control systems (e.g., GitLab, Azure Repo)
- Exposure to MYSQL, MSSQL and ORACLE databases
- Exposure to agile development methodologies.
- Experience with automated testing frameworks for API development.
- Familiarity with microservices architecture, cloud services and containerization tools (e.g., Docker, Kubernetes)
- Knowledge cloud and web applications framework and tools is an advantage.
